Goals and Objectives: This course will survey the major events and themes of the history of the United States from the end of reconstruction to the end of the cold war.

Ralph E. Young, ed., *Dissent in America, Volume II, Since 1865*.

Evaluation: There will be two exams, a midterm and final. In addition, there will be a number of quizzes and writing assignments. Details are given in a separate evaluation document.

Grades: Grades will be calculated as follows:

The grading scale: 90% or above = A; 80%-89% = B; 70%-79% = C; 60%-69% = D; below 60% = F
