Participant/Guardian understands that participation in this activity is voluntary and not required by USA. In consideration of USA permitting the Participant the opportunity to participate in this activity, Participant/Guardian, in full recognition and appreciation of any and all risks, hazards, or dangers inherent in this activity, including transportation to and from related activities, to which Participant may be exposed, does hereby agree to assume all of the risks and responsibilities surrounding participation in such activity.

Participant must obtain his/her own insurance coverage, and provide proof thereof for participation in this activity.

Participant/Guardian accepts full responsibility for the equipment issued to Participant by USA. Participant/Guardian agrees to return all issued equipment, or money for replacement costs, to USA immediately upon request. Participant/Guardian is responsible for lost or stolen equipment regardless of the cause. Participant/Guardian understands that USA may put a hold on Participant's grades/registration if all equipment, or replacement money, is not returned or provided as required.
