Understanding the Degree Audit

Once the Degree Audit is displayed you will be able to view "buckets" of information related to the student's courses. Not every student will have all of these buckets on his/her audit. These are described and illustrated below:

Courses in Excess of Degree Requirements

"Courses in Excess of Degree Requirements" are classes that have been completed, but do not meet any requirement toward a degree. Credits earned for these courses may still be applied toward the degree sought.
