Biographical Note:

The Gulf Coast Center for Holocaust and Human Rights Education promotes Holocaust Education and remembrance of the Holocaust and its victims through training teachers for Holocaust and human rights education, honoring the victims of the Holocaust through instruction and memorials, applying lessons from the Holocaust to contemporary living, and supporting Holocaust scholarship. Each individual file contains biographical information as available.

Scope and Content:

This collection includes transcribed interviews, news clippings, original prose, poetry, and memoirs, photographs, original documents, reparations statements, research materials, facsimiles and correspondence. These materials give a rough sketch of each survivor's experience and document key moments such as immigration, naturalization, internment, or reparations. The materials are unevenly distributed, with some files containing only curated secondary sources. The strongest files include primary documents and first-person narratives.

Provenance:

Acquired by gift from various sources. Received from Jerry Darring, as a representative of the Gulf Coast Center for Holocaust and Human Rights Education.

Arrangement:

Collection is arranged at folder level alphabetically by survivor's name.
