This collection contains correspondence, printed material, and photographs which document the work done by a group of volunteers to bring attention to the abandoned Jewish cemetery at Claiborne, Alabama. In addition, there are printed materials exploring the history of Claiborne, and specifically its Jewish history. Also included is a list of graves and some genealogical work related to those buried in the Claiborne Cemetery. The papers documents the service of Mobile attorney, Lawrence Voit as an organizer of the project. Voit solicited the assistance of other regional Jewish organizations as well as monetary support to help cover the restoration project. The cleanup work was done by a group of young volunteers from the Henry S. Jacobs Camp in Utica, Mississippi during the Summer of 2000.
